# ZaHa

ZaHa means "heart" in the local Huarpe Indian language of Mendoza. This wine is meant to represent the "heart" of the privileged Malbec terroir of Altamira. This high altitude (4,000' elevation), cool climate growing area of Altamira has a very unique soil profile which is at the "heart" of ZaHa.

The soils of Altamira are very diverse, with patches of sandy, rocky and silty soils dispersed throughout the vineyard. At the moment of harvest, each soil profile imparts distinct aromatic and flavor profiles to the Malbec fruit - floral notes in the sandy patches, stony minerality in the rocky areas, and dark fruits in the silty soils. The combination of these profiles lends excellent complexity to the final wine. The 90% Malbec fruit is co-fermented with small amounts of 8% Cabernet Franc, 2% Petit Verdot for additional complexity and concentration. ZaHa - the heart of Altamira.
